

## EXCLUSIONS

ACCF will NOT pay compensation in the following situations:

- Driving under the influence of alcohol over the prescribed limit, or under the influence of drugs.
- Being convicted of an offence of driving with an excess of alcohol or blood alcohol concentration over the prescribed limit.
- Failing or refusing to permit a breath test or a specimen of blood to be taken.
- Not holding a valid driving licence authorising that person to drive the motor vehicle of the class or use for which it is registered.
- Failure to comply with all the conditions of the driving licence.
- Being convicted of an offence for any act or omission that directly caused the accident.
- Attempted suicide or suicide
- Any injury or death that did not directly arise from the accident.
- Owner of a vehicle who has failed to pay the Motor Vehicle Levy.
- Personal injury or death caused by deliberate self-injury.
- Personal injury or death as a result of an accident arising out of and in the course of employment where the injured or deceased person is not a worker.

## **WHO IS ENTITLED TO CLAIM COMPENSATION?**

Victims or their personal representatives of motor vehicle, employment & school accidents may be entitled to compensation as follows:

All passengers, drivers (inside registered motor vehicles), pedestrians & by-standers who suffer serious injuries (permanent incapacity) or death from a motor vehicle accident. This includes cyclists & motor cyclists who are victims of a motor vehicle accident.

All workers who suffer serious injuries (permanent incapacity) or death as a result of an accident arising out of and in course of employment. This includes any incident that causes a prescribed disease.

All pupils who suffer serious injuries (permanent incapacity) or death as a result of an accident occurring on any school premises or during a school event or activity.

## **HOW MUCH COMPENSATION IS PAYABLE?**

The following amounts of compensation are payable;

- ♦ The payment for death is \$75,000.00
- ♦ The maximum payment for 'personal injuries' (permanent incapacity) is \$150,000.00

*(How much is paid will depend on the extent of the injuries)*

## **NOTE FOR EMPLOYERS**

Employers do not need to pay anything to ACCF. They just need to continue to pay their FNU levy and must obtain a Compliance Letter from the Levy & Grants Department at FNU even if exempted. For any queries in respect of the FNU levy and Compliance Letter please contact or email;

## **DUTIES OF EMPLOYERS & SCHOOLS**

### **DUTY TO PAY TWO-THIRDS WEEKLY WAGES**

An employer must pay the employee a weekly payment of two-thirds of the weekly earnings which the employee was earning at the time of the accident. This should be paid for the period the employee is certified unfit to attend work as a result of the employment accident.

### **DUTY TO REPORT**

If a worker or a pupil suffers personal injury or dies as a result of an employment or school accident, the worker's employer or the pupil's controlling authority must report the accident using ACCF Form 01.

- ♦ **Personal Injury: report within 14 days**
- ♦ **Death: report within 7 days**
